4. Eligibility criteria for submitting quotation

- (i) The manufacturer should be a reputed concern, having presence in multiple countries.
- (ii) Vendor must have working office and service center at Kolkata.
- (iii) The manufacturer must have business in relevant field in India for at least 10 years.
- (iv) In case of Proprietorship and Partnership Firms and Company to Tax Audited Report in 3CD Form is to be furnished along with Balance Sheet & Profit and Loss A/c. for the last 3 (Three) years (year just preceding the current Financial year will be considered as year—1). [Non-statutory Documents]
- (v) Declaration regarding Structure and Organization duly signed by the applicant to be submitted along with application.
- (vi) A prospective vendor shall be allowed to participate in a single job either in the capacity of individual or as a partner of a firm. If found to have applied severally in a single job, all his applications will be rejected for that job.
- (vii) Where there is a discrepancy between the unit rate & the item total amount resulting from multiplying the unit rate by the quantity, the unit rate quoted shall govern.
- (viii) The Partnership Firm shall furnish the registered partnership deed and the company shall furnish the Article of Association and Memorandum. [Non-statutory Documents]
- (ix) Where an individual person holds a certificate in his own name duly issued to him by the company or the firm of which he/she happens to be a director or partner, such individual person, either belonging to an appropriate cadre officer of the company or an authorized partner of a firm, having a registered power of attorney empowered by the board or by the firm shall invariably upload a copy of registered power of attorney showing clear authorization in his favour to upload such quotation.
- (x) No mobilization / secured advance will be allowed.
- (xi) In connection with the work, Arbitration will not be allowed.
- (xii) Quotation shall remain valid for a period not less than 120 (one hundred twenty) days after the dead line date for Financial Bid/Sealed Bid submission. Quotation valid for a shorter period shall be rejected by the Principal, Vijaygarh Jyotish Ray College, as non-responsive.
- (xiii) The Agency will be liable to maintain the work at working portion at the appropriate service level to the satisfaction of the Principal at his/her own cost for a period of 1 (one) year from the date of completion of the work. If any defect/damage is found during the period as mentioned above vendor shall deliver the same item at his/her own cost expense to the specification at par with instant project work. Failure to do so, penal action against the Agency will be imposed by the college as deem fit. The Agency will have to quote the rate considering the above aspect.
- (xiv) All vendors who are accepted in the technical bid are requested to be present in the office of the Principal, Vijaygarh Jyotish Ray College during opening the financial bid.
